The Categories of information that we collect, process, hold and share include:

- Personal - name
- Characteristics - gender, age
- Contact details - address, e-mail, telephone numbers

- Qualifications - where relevant

Why we collect and use information:

- We keep donor information so that
 - we can ask them to donate again
 - we can ask for gift aid declarations
 - we can keep them up to date with the work that the charity is doing
- We keep information on recipients of grants so that
 - we can contact them for information of how our grants are making a difference
 - we can contact them to find out if we can be of any further help to them
 - we can keep them up to date with the work that the charity is doing
- We keep information on external providers so that
 - we can contact them when we need to use their services
 - we can keep them up to date with the work that the charity is doing

The lawful basis on which we process this information:

- EU General Protection Regulation (GDPR) which will take effect from May 25th 2018, including Article 9 'lawfulness of processing'

Storing this information:

- Information will be stored electronically - consent forms will also be stored as hard copies

Sharing of data - we would share data with:

- HMRC for gift aid declarations
- The Charities Commission for accounting purposes
- The general public through our website on donations made, events held and through our blogs
- Where appropriate notice will be given prior to personal data being shared with outside agencies

Retention Period

- Whilst working with donors, consultants and receiving charities and for five years after those relationships come to an end.
